1. FUNDRAISING:

2. TUITION:

3. TUITION REFUND INSURANCE PLAN *(the premium cost is 3.2% of adjusted tuition & program/supply fees):*

I have received and read the enclosed brochure detailing the terms and conditions of coverage concerning this Plan. In view of the obligation for tuition and program/supply fees, I understand that the Tuition Refund Plan premium will be billed to me in June. **If I would like to decline the Tuition Refund Plan, I will do so by notifying the AWS Business Office via email at accounts@aurorawaldorfschool.org or in writing. AWS Business Office must be notified by August 1, 2017 by e-mail or in writing if choosing to decline the insurance.** Without the Tuition Refund Insurance, there will be no refunds of tuition after the August 1st deadline noted in the contract. If participating in the Tuition Refund Plan, I authorize the school to collect any claim payment to which I am entitled under the Tuition Refund Plan and credit it to my account, paying any excess to me.
